This request also should be understood to include any guidance received by your office or requested by your office on how to handle any "ratification" made after the original March 22, 1979 deadline through the June 30, 1982 deadline, and similar requests or guidance pertaining to any alleged "ratification" of the ERA after the June 30, 1982 extension deadline.
