Dear Sir or Madam

This is to request any documents relating to actions taken by the legislatures of Illinois and Nevada voting to "ratify" the Equal Rights Amendment originally proposed by the Congress to the several states on March 22, 1972. I am not looking for copies of the official resolution sent to your office by the legislatures, but other communications, including emails, which could have led the Archivist of the United States to declare those supposed ratifications to be valid.

I previously made two inquiries to the Archives requesting such materials and I was recently advised to contact your office. My requests for these records were made on February 11, 2019 and on March 4, 2019. So this is my third request for such information. I am including copies of my two earlier requests.

I am making this request to you pursuant to the Federal Freedom of Information Act. My FOIA case number is RDT1R-19-19161-JAF. Because I have been redirected and delayed in receiving the material I have requested, I would appreciate a prompt response to this request.

Consider this note permission to cover up to \$200.00 in copy costs, so as to not further delay receiving documents relating to Illinois and Nevada regarding any efforts to ratify the Equal Rights Amendment which were forwarded to your office or any federal office.

Additionally, I request any acknowledgment of receipt of such transmissions from Illinois and Nevada by your office or the office of the National Archives as well as any responses sent either by your office or the National Archives to Illinois or Nevada to representatives of those respective legislatures concerning the legality and constitutional validity of such legislative actions.
